D6 Coin doesn't just give Esports fans their own custom cryptocurrency but creates a token with utility. Integrated into our world-class Esports ecosystem and tournament hosting service, D6 Coin's value isn't simply speculative, it can be exchanged for competitive tournaments and wagers, learning materials, coaching and more.



D6 COIN

The D6 Coin is the basic currency of the Division 6ix Ecosystem. It can be earned in various quantities, swapped from other native digital currencies or purchased in bulk at an affordable price. D6 Coin is built on a gamified acquisition, retention and spending structure. The D6 Coin will be the primary means of exchange on the Division 6ix online gaming platform and arenas. Here are some of the uses of the D6 Coin on the Division 6ix online gaming platform and arenas;

- **Tournaments:** The D6 Coin can be used to take part in various tournaments on the Division 6ix online gaming platform and arenas

MARKET GAP

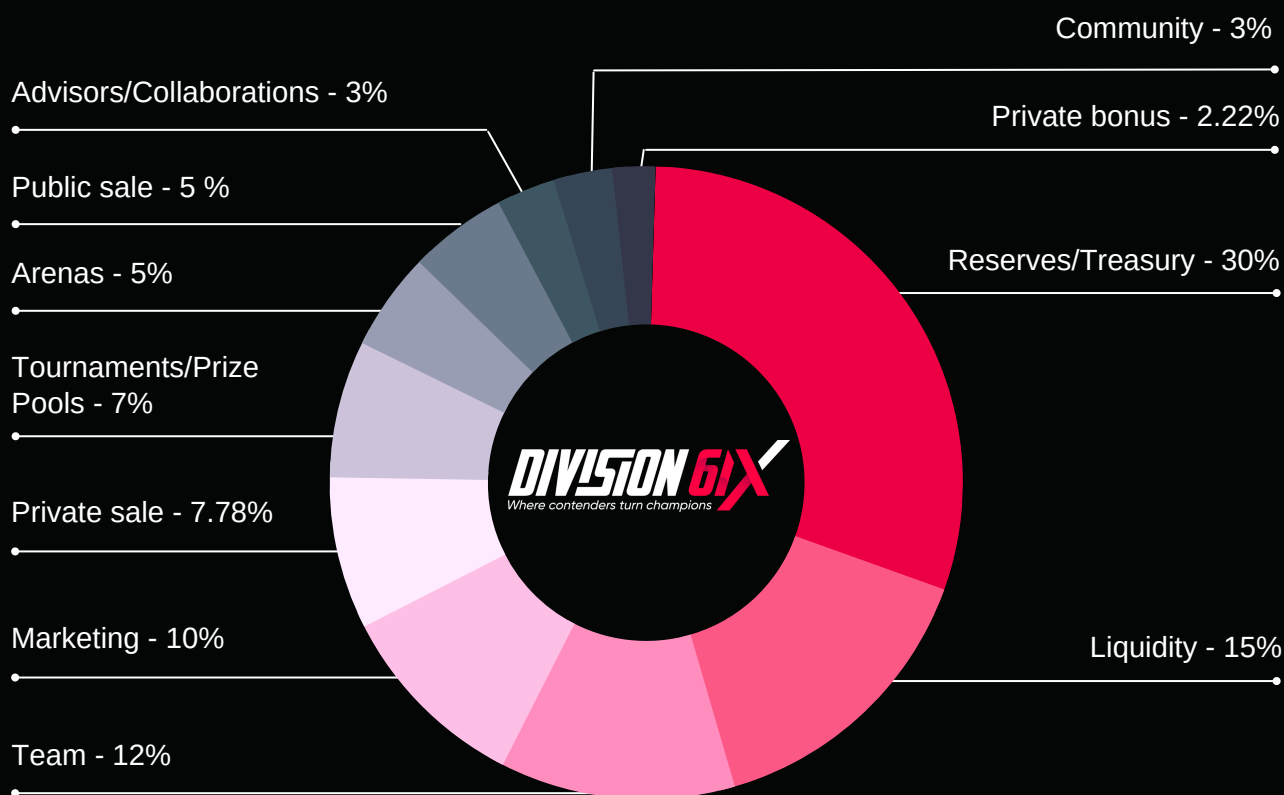

TOKENOMICS

- **Token name:** D6C (D6 Coin)
- **Token type:** D6C is a Binance Smart Chain token
- **Total supply:** The total supply of BCG is 300 million tokens.
- **Token utility:** D6C is used as the primary utility token on the Division 6ix platform. It can be used to compete in tournaments & wagers, earn rewards, access VIP levels, participate in the referral program, and purchase items on the marketplace.
- **Token burning:** Division 6ix will put in place a token burning mechanism that helps to maintain D6 Coin's value by reducing the overall supply. Whenever a user wagers or withdraws funds, a small percentage of D6C is burned, reducing the overall supply.
- **Token buyback:** Division 6ix will have a token buyback program in place that allows the platform to purchase D6 Coins on the open market. These tokens are then burned, reducing the overall supply and increasing the value of the remaining tokens.
- **Token staking:** Division 6ix will allow users to stake their D6 Coins to earn rewards. By staking D6C, users will earn a percentage of the platform's revenue, as well as additional rewards and benefits.

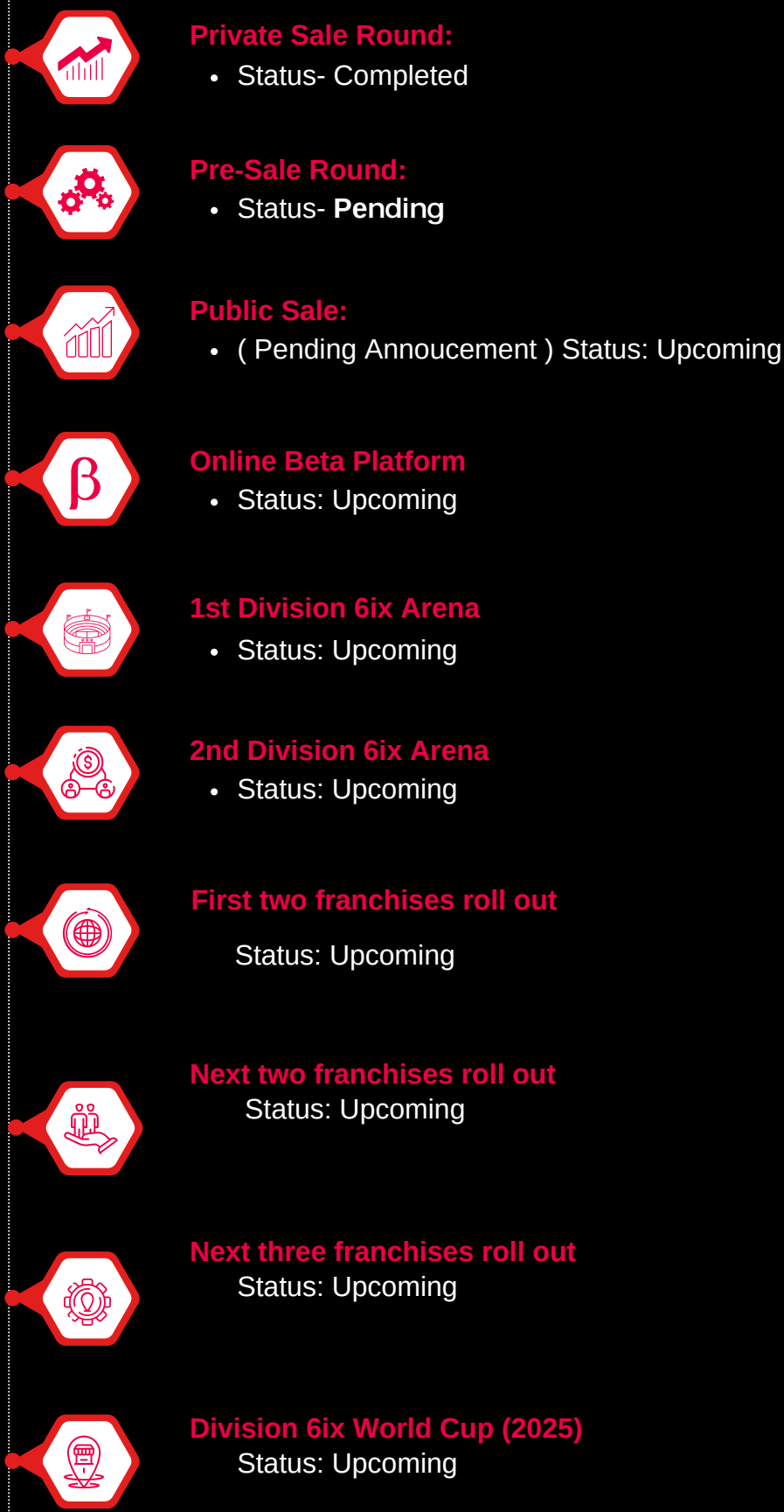

REVENUE SOURCES

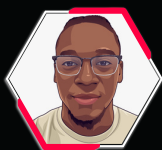
There are multiple revenue sources that Division6ix as a company will obtain as of the date and time of this whitepaper. We project that additional revenue sources will emerge as opportunities open in the future.

- 1** First and foremost, Division6ix's ICO will act as a significant revenue stream. As mentioned in the Technical Development Section, details regarding the ICO will be comprehensively stated in the D6IX ICO section. However, from a funding perspective, the money made from the sale will be the main source of funding for all the initiation projects.
- 2** The second source of revenue for Division 6ix will be in form of the D6ix wager fees. When player wager amongst one another, Division 6ix will deduct a percentage from the total pool in terms of fees. This revenue stream relies on the assumption that the volume of transactions that occur at any given time is high enough to produce a substantial income. It is for this reason that operating on a global level is crucial.
- 3** The third source of revenue is sponsorship & advertising. In the Competitors and Market Penetration section, the importance of sponsorship was highlighted. Division6ix expects to earn money from brands all over the world who wish to sponsor the company, the teams, or any individual players. These sponsors include big brands like Red Bull and Coca Cola, but also service-related brands like Banks and Fintech companies.
- 4** The fourth source of revenue will be transaction fees: Division 6ix will charge transaction fees on deposits and withdrawals. These fees are typically a percentage of the transaction amount and will help to cover the costs of processing the transactions.
- 5** The fifth source of income will be through the Division 6ix affiliate program: Division 6ix will have an affiliate program that allows users to earn commissions by referring new users to the platform. The program will pay a percentage of the revenue generated by the users that are referred by affiliates.
- 6** The sixth source of income will be the VIP system: Division 6ix's VIP system will generate revenue by charging users a fee to access the higher VIP levels. The higher the VIP level, the more benefits and rewards users can receive, and the higher the fee to access that level.
- 7** The Seventh source of income will be the sale of merchandise; ranging from branded Division 6ix gaming equipment's to different fashion collaborations and collections.

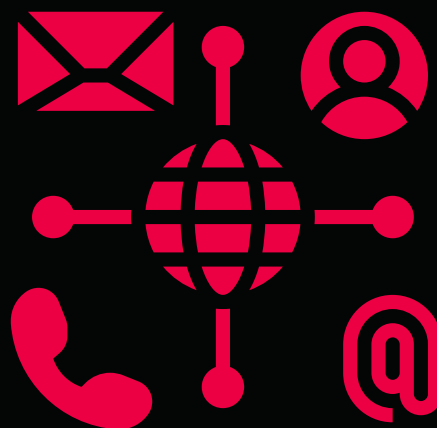

LEGAL AND REGULATORY APPROVAL

While the esports market has been growing at a significant pace, regulations have not been able to keep up with the increasing nuance. However, due to the familiarity of the standardised framework that Division6ix will bring, it may be easier to determine which laws apply the business practices of the organisation. For example, Gambling, sports, prize promotion, advertising, and data privacy laws may be considered. The laws and regulations may also apply differently depending on a number of questions, such as whether the activities are being carried out online or in a venue of some sort; whether the nation in which the activity is taking place is recognised esports as an official sport; what is the scope of potential prize options; what NFTs can be bought or sold on the Galaxy market; what the technical requirements are; and what the actual risks are from a technological, operational, and public opinion perspective. An understanding of the laws that could apply to the various stakeholders within the industry is also crucial for the legal success of Division6ix.

For example, event organisers, media companies, online platforms, sponsors, video game publishers, as well as the players and viewers themselves. Each of these stakeholders, regardless of their position, want to maximise their profits, exploitation rights, and utility. Simply the corporate structure of Division6ix will need to be moulded in accordance with the laws and regulations of the various regions it plans to expand towards. Contracts for players will also need to be designed to accommodate for various legal scenarios and positions, including the process of contracting with major streaming sites like YouTube and Twitch in the event of an extreme influx of viewership for any player, team, organisation, or event. According to Esports Laws of the World by DLA PIPER, the applicable governing laws in the United Kingdom are as follows: Gambling Laws · Gambling Act 2005 s6 – Gaming · Gambling Act 2005 s9 – Betting · Gambling Act 2005 s11/339/Schedule 1 – Prize Competitions · Gambling Act 2005 s12 – Pool Betting · Gambling Act 2005 s13 – Betting Intermediary · Gambling Act 2005 s14 – Lottery · Gambling Act 2005 s16-18 – Cross-Category Activities The Gambling Act largely applies to Great Britain Only, separate rules may be held to apply in Northern Ireland. The Government has the power to provide that a particular activity is to be treated as a sport outside the definition of gaming.
